Your complainant, Emma A. Burkart, brings this her bill of complaint against the respondent, Frank Barchard, Sr., and humbly complaining says:

- 1. That the complainant is abbona fide resident citizen of Cullman County, Alabama, and is over the age of twenty-one years; and that the respondent is a bona fide resident citizen of Baldwin County, Alabama, and is over the age of twenty-one years.
- 2. That the complainant and the respondent are joint owners or tenants in common of the following described real estate situated in Baldwin County, Alabama, to-wit:

A part of the William Kee Spanish Grant
Sec. Twelve (12), Township Nine (9),
South, Range Five (5) East, more particularly
described as follows: Commencing at the intersection of the Township line between Townships Eight (8) and Nine (9) South Range Five
(5) East and the east line of the William Kee
Spanish Grant Sec. Twelve (12) Township Nine
(9) South Range Five (5) East, thence west
eighteen hundred five (1805) feet, thence south

without a sale thereof and that a sale of said lands is necessary for the purpose of division. Complainant avers that she has employed an attorney to file this bill and prosecute this suit.

WHEREFORE, the premises considered, complainant prays that your Honor will take jurisdiction of this cause; that the said Frank Barchard, Sr., be made a party defendant hereto; that proper process be issued to be served on him to bring him into court to plead, answer or demur to this bill within the time and in the manner required by law; that upon final hearing hereof a decree be granted for the sale of the lands described in the bill for the purpose of division; that a reasonable solicitor's fee be ascertained and allowed to the solicitor of complainant for filing this bill and prosecuting this suit. And for such other relief, general and special, as may be agreeable to equity and good conscience.
