PRAYER FOR PROCESS

Your Oratrix prays that the Court will take jurisdiction of the cause made by this Bill of Complaint and that the usual process of this Honorable Court do forthwith issue to the Respondent requiring him to appear and plead, answer or demur to the said Bill of Complaint within the time and under the pains and penalties prescribed by law and the rules of this Honorable Court.

PRAYER FOR RELIEF

Your Oratrix prays for the following separate and several relief:

1. That the bonds of matrimony heretofore existing between your Oratrix and the said Respondent be dissolved and that she be forever divorced from him on the ground of abandonment.

- 2. That your Oratrix be granted the permanent custody and control of the minor child, Bobby Leon Handcock.
- 3. Your Oratrix further prays for such other, further and general relief as she may be equitably entitled to the premises considered.
