TO THE HONORABLE F. W. HARE, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, SITTING IN EQUITY:

Your Petitioner, Anna Olson, respectfully represents unto the Court and your Honor as follows:

1. She is a resident citizen of Baldwin County, Alabama, over twenty-one years of age and is the mother of Carl Victor Olson, also known as Carl Olson and Carl V. Olson, a minor who was eighteen years of age on November 12, 1944, who resides with Petitioner in Baldwin County, Alabama when not in the merchant marine service.

2. Petitioner further shows unto the Court and your Honor that the said minor owns real property situated in Baldwin County, Alabama, which property cannot be conveyed by him without long and expensive court procedure, that he has an opportunity to sell the said property for a good price and that it is to the best interest of the said minor aforesaid that he be relieved of the disabilities of non-age. Said minor has no guardian.

THE PREMISES CONSIDERED Petitioner prays that your Honor will make and enter a Decree relieving the said minor, Carl Victor Olson, also known as Carl Olson and Carl V. Olson, of the disabilities of non-age and that such other proceedings be had and such further orders and decrees be made as may be necessary in the premises to invest the said minor with the right to sue and be sued, contract and be contracted with, buy, sell and convey real estate and other property and generally to do and perform all acts which he could lawfully do if he were twenty-one years of age.

Petitioner further prays for such other, further and general relief as she may be equitably entitled to the premises considered.

DECREE RELIEVING MINOR OF DISABILITIES OF NON-AGE

This cause coming on to be heard on this date is submitted for Decree upon the Petition of Anna Olson, the mother of Carl Victor Olson, also known as Carl Olson and Carl V. Olson, a minor eighteen years of age to relieve the said minor of the disabilities of non-age, the written consent and waiver of notice of the said minor, service of a copy of the said Petition upon the said minor, and upon the affidavit of Muriel Hallberg, and it appearing to the Court from the Petition and the said affidavit that the said minor is over eighteen years of age; that he and the Petitioner are each residents of Baldwin County, Alabama; that he is entirely capable of managing his own affairs and the Court being satisfied that it is to the best interest of the said minor that his disabilities of non-age be removed IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. That the minor, Carl Victor Olson, also known as Carl Olson and Carl V. Olson, be, and he is hereby relieved of all of the disabilities of non-age and invested with the right to sue and be sued, contract, buy, sell and convey real estate and personal property and generally to do and perform all things, acts and deeds which he could lawfully do if he were twenty-one years of age.
2. The Register of this Court is hereby ordered and directed to file a certified copy of this Decree in the Probate Court of Baldwin County, Alabama, and tax the costs thereof with the other costs of this proceeding.
3. The costs of this proceeding are hereby taxed against Petitioner, for which execution may issue.
