My name is John P. Gottler. I live at Elberta in Baldwin County, Alabama. I am the President of the Elberta Farmers Club, a corporation, with its principal place of business at Elberta, in Baldwin County, Alabama. I have held such office during the past 9 years. The Elberta Farmers Club is a corporation duly organized and existing under the laws of the State of Alabama. The Baldwin County Colonization Company is a corporation, and for a mumber of years did business in Baldwin County, Alabama, where it owned large tracts of land and kept representatives here in the County at all times. The Baldwin Colonization Company several years ago, sold all or practically all property owned by it in Baldwin County, and has not since that or practically all property owned by it in Baldwin County, and has not since that time, kept an agent, or representative in this County upon whom service can be effected. I have made inquiry from those formerly associated with the corporation as to whom service could be perfected upon, and have been unable to find out.

There is no agent in the County. The Elberta Farmers Club is the owner in fee simple and in the actual possession of the lands described in the bill of complaint in the cause, and being Lot 2, Block 3, Elberta, according to plat thereof, of record in the office of the Probate Judge of Baldwin County, Alabama, in Map Book 1, page 21.

There is no suit pending to test the Complainant's title to, interest in, or its rights of possession to said land. The Complainant, the Elberta Farmers Club, obtained title to the said lot by purchase from the State of Alabama, by deed dated January 31, 1945; that the original deed is hereto attached and marked exhibit "A".

The title to the said land stands upon the record in the Probate Court of Baldwin County, Alabama, in the name of Elberta Farmers Club.

The land described in the bill of complaint was sold in the name of Baldwin County-Colonization Company, by Tax Collector, to the State of Alabama, on July 8, 1931, for the taxes due for the year 1930. No taxes have been paid on the property since that time. No one has paid any taxes on the property other than the Elberta Farmers Club, since 1931. The records at the Court House have been searched and the only parties claiming any interest to the said lot are, The Elberta Farmers Club, a corporation, and Baldwin County Colonization Company, a corporation.

Albert Haupt, a witness for the Complainant, being first duly sworn, deposes and says:

My name is Albert Haupt. I am Treasurer of the Elberta Farmers Club, a corporation, the Complainant in this cause. I am acquainted with all the records of the Elberta Farmers Club.

I am also acquainted with the Lot described in the bill of complaint in this cause. The Lot is vacant, with no improvements thereon. The Baldwin County Colonization Company, at this time does not have a representative in this County. It is my information, obtained from inquiries of parties formerly connected with the Baldwin County Colonization Company, that it some years ago ceased doing business.

It has conducted no kind of business in this County for several years. It is my information, from old residents of Elberta, that the Lot in question was intended by the Corporation as a market place. The Elberta Farmers Club, a corporation, consists of many residents of Elberta and vicinity. The property involved is by the corporation, going to be used as a civic project, that is, it is planning to erect thereon, a Quick Freeze Plant, in fact, plans have already been drafted and a part of the material has been placed on the property. No one has for the past 25 years exercised any rights of actual occupancy, or possession of the said Lot, except the Elberta Farmers Club.
