

TO HONORABLE F. W. HARE, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, SITTING IN EQUITY:

Comes your Complainant, Minnie Ruth Greer, and humbly complaining against Mace Richard Greer, Defendent, respectfully shows unto your Honor and this Honorable Court as follows:

7.

That your Complainant and the said Defendent are both over the age of twenty-one years and residents of Baldwin County, Alabama; that the Defendent has the last few weeks been temporarily so journing in Mobile, sleeping in the home with his mother, at 502 Palmetto Street, Mobile, Alabama;

2.

That your Complainant and the said Defendent are husband and wife, having entermarried in Uriah, Baldwin County, Alabama

in the year 1937; that there was born to them a child whose name is Mace Richard Greer, Jr., now of the tender age of six (6) years.

3.

That the Defendent is a man of cruel and ungovernable temper and on the evening of June 3, 1945, unmercifully beat this Complainant with his fist and threatened to shoot her, and made an effort to do so, and but for Complainant's getting out of the way, would have shot her, and on the morning of June 4 drove her from her home in Bay Minette, and told her not to return, and if she did, he would kill her. Complainant was without fault. From his conduct and treatment of her, Complainant has reasonable cause to believe and does believe that should she continue to live with the Defendent, he would do her bodily harm attendent with danger to her life or health;

4.

That Defendent is not only a man of cruel and ungovernable temper but also a habitual drunkard, and is not a suitable man to have the care and custody of the said miner child, but he has carried the said child to Mobile with him and denied the custody of the child to this Complainant, and, as well, denied said Complainant the right to see the said child, and Complainant is solicitious that her said child is not receiving the proper care and attention.

The Defendent is employed at one of the shipyards in Mobile, and earns \$250.00 to \$300.00 a month, and is amply able to properly support and maintain your petitioner and said child, and, as well, to pay a reasonable attorney's fee for her solicitors in this cause. Complainant is without funds and without means of support for herself and her miner child and to pay her solicitor in this cause.

THEREFORE, Complainant prays this Honorable Court will take jurisdiction of the cost made by this bill of Complaint and

will by proper process make the said Mace Richard Greer party

Defendent hereto, and require him to plead, answer, or demur to this

bill of Complaint within the time and under the penalties pre
scribed by law and the practice of this Honorable Court.

Complainant further prays that pending this cause this
Honorable Court will order a reference to determine a reasonable
attorney's fee for Complainant's attorneys and a reasonable
alimony for Complainant pending this suit, and that this Honorable Court will take custody of the said Mace Richard Greer, Jr.,
miner child, and deliver said child into the custody of Complainant
subject to the final order of this Honorable Court.

Complainant further prays that upon the final hearing of the cause made by this Bill of Complaint, this Honorable Court will make and enter a decree forever disolving the bonds of matrimony existing between this Complainant and the said Defendant, and that this Honorable Court will further order, adjudge, and decree that this Complainant have the custody of the said Mace Richard Greer, Jr., and that such child be placed in the custody of this Complainant, and Complainant further prays that this Honorable Court will make and enter a decree fixing an amount to be paid to this Complainant as permanant alimony by the said Defendant at such times as to this Honorable Court shall seem proper; and order and decree that said Defendant pay the same under penalty of the law; and Complainant prays for such other, further or different relief as in equity and good conscience she shall be entitled to receive.
