Complainant further prays that your Honor will, upon a hearing hereof, enter an order and decree, granting to her an absolute decree of divorce, forever barring the bonds of matrimony existing between her and the Respondent; Complainant prays for such other, forther, different or general relief as she may be in equity and good conscience entitled to receive, and as in duty bound she will ever pray.
