

My name is Bertha Carvin. I am 39 years of age. I married Bernette Carvin at Pensacola, Florida, on November 11, 1939, and we lived together as man and wife until about January 27, 1940. Bernette later went to live with a woman named Georgiana DeBose in her house. They lived together for some time with no one else in the house. I think that this was about 1943. Since then I have seen him with other women. Last Sunday night I saw him with another woman. He has been "going with this woman for about a year. This girl is about 22 years of age and my husband is about 45 years of age. I can't say for sure whether or not they have committed adultery too, but it looks very suspicious. I have lived in Baldwin County since 1936.

My name is Ambus Pettibone. I am 36 years of age. I know Bernette Carvin and Georgiana DeBose. I have seen Bernette go into Georgiana's house every night and go away every morning for about a year. No one else was in the house at the time. This happened some time ago.


