On June 2, 1924, I was married to Henry Doering, the Defendant, ~~xxxxxx~~

On or about October 5th, 1927, Henry Doering, the defendant, abused me and beat me in the back with his fist and cursed me and threatened me and committed actual violence on my person, attended with threats and danger to life and health, and from his acts and threats I had a reason for apprehension that he would take my life. This occurred at Elberta, Alabama. That for more than a year previous to October 5th, 1927, Henry Doering constantly abused and threatened me, and the only reason he did not commit actual bodily harm on me was the fear he had of my father and brother. That for more than a year prior to the separation, October 5th, 1927,

... he failed and refused to support me and our child, Elizabeth Doering, who is now three years of age, and I was forced to work for our support, and called on my mother to help take care of our child.

I was always a dutiful wife, and my husband had no cause of complaint, and the said acts of violence on his part were wholly his fault and I never gave him any reason for said cruel treatment.

That there was born of the marriage of Henry Doering and myself, a girl child, named Elizabeth Doering, who is now three years old. Henry Doering is not a fit person to raise and care for this child, and he had never in any way since he left me contributed to the support of said child, and I am financially able and well qualified to take charge and raise said child

Catherine Doering

Clara Krehling, on being sworn, testified as follows:

My name is Clara Krehling, and I live at Elberta, Alabama.

I am the sister of Catherine Doering. I know Henry Doering, the defendant, and have known him for several years. I know that he is over the age of twenty-one years. I know that Henry Doering is not now living in the State of Alabama, but when last heard from he was living in Milwaukee, Wisconsin. I know that Henry Doering and my sister Catherine were married on or about June 2, 1924.

I was present on October 5th, 1927, when Henry Doering

hit my sister, Catherine, in the back with his fist, and abused her and threatened to take her life. I was also present

at other times and from his acts and threats on this occasion

and at other times I think my sister had reasonable apprehension

that he would take her life. Henry Doering and Catherine

Doering have a little girl, Elizabeth Doering, about three years

old. My sister has taken care of this child, looked after its

care and comfort, and is fully capable both financially and

otherwise in caring for said child. As far as I saw my sister,

Catherine always treated her husband well and as a dutiful wife

and he never had any cause for complaint, but his bad treatment of his wife was wholly his fault. From what I know of Henry Doering

and his character, I do not consider him a proper person
to have the custody and control of the child, Elizabeth,
Doering, and I think it is to the child's welfare that it
be and remain to the custody and care of its mother, Catherine
Doering.
