Comes now Calla Mai Tanner, the defendant in the above entitled proceeding, and respectfully moves the Court to quash the indictment heretofore returned in this proceeding and as grounds therefor says as follows:-

1. Defendant says that before this indictment was returned she was required to attend and appear before the same Grand Jury that returned said indictment and to give evidence touching the offense charged against her, without her consent, and that she was thus deprived of her Constitutional rights in connection with the matters set out in said indictment.

2. Defendant says that on a day prior to the time that this indictment was found by the Grand Jury and returned to the Court, this defendant was subpoenaed and compelled to attend and appear before the said Grand Jury to give evidence in the case wherein she was charged with the offense of receiving stolen property, and that said defendant did so appear before said Grand Jury and was then and there required to make statements in answer to their interrogatories touching the crime charged against her and in relation to and in connection with the matters charged in said indictment, and defendant says that she was not advised by the Solicitor in charge of said Grand Jury of her Constitutional rights, and that at the time she was so compelled to testify concerning said matters the Solicitor in charge of said Grand Jury and the said Grand Jury well knew that the defendant was charged with and suspected of the crime named in the indictment. And defendant says that, after she was so compelled to testify


in said matter, the said Grand Jury returned this indictment against her.
