

## WRIT OF INJUNCTION.

To any Sheriff of the State of Alabama -- Greeting: that

We, command you/without delay you execute this Writ, and due return thereof, how you have executed the same make to us immediately.

To. H.J. Champion and Herbert J. Champion, individually and as partners doing business as H.J. Champion and Son.

WHEREAS, George C.Meyer, has this day filed a bill of Complaint in said Court against H.J.Champion , and Herbert J. Champion , individually, and &&&&&& as partners doing business as H.J. Champion and Son, praying among other things , that this Court will grant a writ of injunction against H.J. Champion and Herbert J. Champion individually and as partners doing business as H.J. Champion and son, enjoining them and each of them ,individually, and as partners from any manner interfering with the lands and timber described in the bill of complaint,

on said Bill of Complaint being exhibited And whereas, to the Honorable Claude A. Grayson, Judge of the Circuit Court of Mobile County, Alabama, on the 7th, day of January, 1927, he did order that upon complainants entering into bond, with sucreties in the sum of One Thousand Dollars, payable to the defendants and approved by the Clerk, and conditioned according to law, a Writ of Injunction, issue out of the Circuit Court of Baldwin County, Alabama, according to the prayer of said Bill; and whereas, bond has been given, as required by said order.

These therefore, are &&&&&&& to command and strictly enjoin you from, mutilating, or destroying the younfg and growing timber and from defacing said proerty in any manner and from trespassing upon or in any manner interfering with the lands and timber described in this Bill as follows:

Fractional part of northwest quarter of Southwest quarter (31) acres); the Northeast quarter of Southwest quarter (20 acres) and Morthwest quater of Southeast quarter (29 acres) the Sou th half of Northeast quarter and South half of Northwest quarter; and Northwest quarter of Northwest quarter all in Section Sevemteen, Township Nine South, Range Four East, containing in all, approximately 280 acres, more or less;

Until further order of the Court, And this you will in nowise omit, under penalty/ Witness T.W.Richerson, as Clerk of said Court, at office , in

Bay Minette, Alabama, this 7th day of January, 1926.
