TO THE HON. THE CIRCUIT COURT BALDWIN COUNTY, ALA-BAMA AND THE HON. JOHN D. LEIGH, JUDGE THEREOF, SITTING IN EQUITY:

Comes your Complainant Verna Adams Rabon and exhibits this, her Bill of Complaint against Robert M. Rabon, the defendant and shows unto your Honor and unto this Honorable Court as follows:-

- l. That both your complainant and the defendant are over the age of 21 years and are bona fide residents of Baldwin County, Alabama, bothnof them having been such residents for the past ten years continuously next immediately preceding the filing of this Bill of Complaint.
- 2. That your complainant and the defendant were married on heretofore to-wit: November 15th., 1904 and lived to-gether as man and wife until to-wit: the early part of 1927, when, on account of the matters hereinafter complained of your complainant was compelled to cease to live with the defendant as his wife.
- complainant and the definedant were residing in Baldwin County,
 Alabama, the defendant on divers occasions committed acutual violence on the person of your complainant, attended with danger to
 her life or health; that he continuously cursed and abused your
 complainant; that he struck her and that the conduct of the defendant was such that your complainant had reason to apprehend the
 commission of actual violence on her person attended with danger
 to life or health.
- 4. That there were born to your complainant and the defendant by said marriage two children, namely: Ernest Rabon, a son, who is 17 years of age and Robert Rabon, Jr., a son, who is 8 years of age; that both of said children reside with your com-

plainatt who is a fit and proper person to have the custody, care and control of them; that the defendant Robert M. Rabon is not such a fit and proper person to have the custody and control of said children.

means of livelihood, unable to earn a living for herself or for said children and is without funds; that the defendant is an experienced naval stores operator and operates at this time turpentine orchards or places in Baldwin County, Alabama. That the defendant is possessed of much real property and is worth from \$50,000.00 to \$75,000.00 in real and persoal property and in cash which he now possesses. That your complainant on account of having no income or funds and not being able to earn a livelihood is not possessed of sufficient money or income to properly prosecute this cause.

PRAYER FOR PROCESS AND RELIEF.

THE PREMISES CONSIDERED, your complainant prays that such orders, decrees, summons and notices be made, entered and issued or caused to be made, entered and issued as will make the said Robert M. Rabon party defendant in this cause, requiring him to appear and plead, answer or demur within the time and under the pains and penalties prescribed by law and the rules and practices of this court; that your Honor will order a reference to be held by the Register of this Honorable Court to ascertain a reasonable amount to be paid by the defendant to your complainant as attorneys fees for complainant in this cause and for alimony pendente lite and for support of your complainant and the said children and that upon the holding of such reference your Honor will decree unto your complainant an amount to be paid to her by the defendant as such attorneys fee, alimony and maintenance suitable to her condition and state in life and as is consistent with the property and earning capacity of the defendant.

That when a final hearing of this cause your Honor will grant unto your complainant a divorce mensa et thora from the defendant and will give and grant unto your complainant the custody and control of said children; that your Honor will further grant unto your complainant a reasonable amount to be paid her by the defendant for the maintenance and support of your complainant and the said children and, as in duty bound, your complain ant will ever pray, etc.

Respondent most emphatically denies the allegations contained in Pargaraph three and demands strict proof thereof.

four in that there were born to the Complainant and the Respondent two children, namely: Ernest Rabon, a son, seventeen years of age and Robert Rabon, Jr., a son, who is eight years of age, but denies the other allegations that both of said children reside with the Complainant; that the Complainant is a fit and proper person to have the custody and care and control of said children but respectfully submits that the Complainant is not a fit and proper person to have the control of said children, but on the contrary that the Respondent is the proper and fit person to have the custody and control of said children.

The Respondent denies the allegations contained in Paragraph five and demands strict proof thereof.

Respondent prays that upon a final hearing of this cause the Court will decree that the Respondent is a proper person to have the custody and control of the children, and that he may have such other, further, different or general relief as the Court may determine that he is in equity and good conscience entitled to receive and as in duty bound he will ever pray, etc.
