Highway 31, a public highway of the State of Alabama, in Baldwin County, Alabama, liquefied gas upon which the excise tax of six cents per gallon upon the withdrawal from storage in the State of Alabama of liquefied gas had not been paid and the payment thereof had not been assumed by a distributor or storer or user licensed by the Department of Revenue of the State of Alabama, contrary to law and against the peace and dignity of the State of Alabama.
