The Grand Jury of said County charge that before the finding of this indictment Ernest Harold Hadley, whose name is to the Grand Jury otherwise unknown than as stated, with intent to steal, broke into and entered a building known as the Louisville & Nashville Railroad Station in or near Perdido, Alabama, in possession of Kimsey Ryals, in which goods, wares, merchandise, money or lawful specie of coin of the United States, things of value, were kept for use, sale, or deposit, against the peace and dignity of the State of Alabama.

The Grand Jury of said County further charge that before the finding of this indictment Ernest Harold Hadley, whose name is to the Grand Jury otherwise unknown than as stated, with intnet to steal, broke into and entered a building known as the Louisville & Nashville Railroad Station, in or near Perdido, Alabama, in possession of Louisville and Nashville Railroad Company, a corporation, in which building goods, wares, merchandise, cash money or lawful specie of coin of the United States, things of value, were kept for use, sale, or deposit,
