THE STATE OF ALABAMA }  
Baldwin County. }

Circuit Court, Fall Session, 1951

The Grand Jury of said County charge that before the finding of this indictment Robert Hines, whose name is to the Grand Jury otherwise unknown than as stated, did falsely personate W. M. Mason, with intent to defraud, and, in such assumed character, received, to-wit, Two Hundred Thirty-five Dollars, lawful money of the United States, the description of which is to the Grand Jury otherwise unknown, intended to have been delivered to the said W. M. Mason, against the peace and dignity of the State of Alabama.

2. The Grand Jury of said County further charge that before the finding of this indictment Robert Hines did falsely pretend to Ruth Stallworth, in substance, that he could cure her of her illness and get the husband of said Ruth Stallworth released from jail, and, by means of such false pretenses, obtained from the said Ruth Stallworth Two Hundred Thirty-five Dollars, lawful money of the United States, the description of which is to the Grand Jury otherwise unknown,

against the peace and dignity of the State of Alabama.
