The Grand Jury of said County charge that before the finding of this indictment Robert Hines, whose name is to the Grand Jury otherwise unknown than as stated, while acting as the bailee of Mazie Agee, did embezzle or fraudulently convert to his own use money in about the amount of Three Hundred Eighty-two Dollars, which said money came into his possession by virtue of said bailment, against the peace and dignity of the State of Alabama.

2. The Grand Jury of said County further charge, that, before the finding of this indictment Robert Hines, whose name is to the Grand Jury otherwise unknown than as stated, feloniously took and carried away, to-wit, fifteen five-dollar bills, seven one-dollar bills, five fifty-dollar bills, two twenty-dollar bills, and one ten-dollar bill, of the value of, to-wit, Three Hundred Eighty-two Dollars in lawful United States currency, the personal property of Mazie Agee,

against the peace and dignity of the State of Alabama.
