

TO THE HONORABLE JOHN D. LEIGH, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, IN EQUITY:

Comes your Complainant Lawrence Joiner and humbly complaining against Fronie Joiner respectfully represents and shows unto your Honor as follows:

FIRST

That both are bona fide residents of Baldwin County, Alabama and have been for more than ten years next preceding the filing of the Bill of complaint in this cause; that both are over the age of twenty one years.

SECOND

That your complainant and respondent are husband and wife, having intermarried at Pensacola, Florida on the 15th day of April, 1918; that they lived together as man and wife until June 4th., 1928.

TH IRD.

That on to-wit, about the first day of June, 1928, and on various other dates, the respondent Fronie Joiner committed acts of adultery with one Jim Jay; that the said acts were committed in Baldwin County, Alabama and without the consent oroapproval of the complainant; that the said complainant did not know of the said acts of adultrey of the respondent until the 4th day of June, 1928; that he did not consent to, approve of or conive at said acts of adultry committed by the said respondent.

FOURTH:

That there was born to said marriage four children, namely, Jesse Willard Joiner, a boy, nine years of age; Lawrence Everett Joiner, a boy, seven years of age, William Shirley Joiner, a boy four years of age and Marvin Earl Joiner, a boy two years of age; that respondent, on account of said acts of adultry, is not a fit and proper person to have the custody and control of said children; that your complainant is a fittand proper person to have the custody and control of said children.

Wherefore your Complainant prays that your Honor will, by the proper process, make the said Fronie Joiner, party respondent to this bill of complaint, requiring her to appear, plead, answer or demur to the samd within the time and under the penalities prescribed by law and the practice of this honorable court.

Complainant further prays that upon the final hearing of this cause, your Honor will grant unto him a decree of absolute divorce forever barring the bonds of matrimony existing between him and the said Fronie Joiner; and that your Honor will enter an order granting unto your complainant Lawrence Joiner, the custody and control of the said children, namely, Jesse Willard Joiner, Lawrence Everett Joiner, William Shirley Joiner and Marvin Earl Joiner; that your Honor will give and grant unto your complainant such other, further, different or general relief as in equity and good conscience may seem meet and proper and as in duty bound, he will forever pray.
