2. The Grand Jury of said County further charge that before the finding of this indictment, JULICE BOYKIN, alias BUD BOYKIN, whose name is to the Grand Jury otherwise unknown, feloniously took and carried away two tires of the value of, to-wit, one hundred forty dollars, the personal property of L. J. Early,

against the peace and dignity of the State of Alabama.
