To the Honorable John D. Heigh, Judge of the 21st Judicial Circuit, -IN EQUITY -

Comes the complainant, William A. Hare, and shows unto your Honor -

- I- That he has been a bona fide resident of the State of Alabama for the three years next preceding the filing of his bill for divorce.
 - 2- That the complainant and the respondent are each over the age of twenty one years; that the complainant is a resident of Baldwin County, Alabama; that the place of residence of the respondent is unknown to the complainant.
 - 3- That the complainant and the respondent were married to each other on the 11th day of March, 1915, and are now and ever since have been husband and wife.
 - That the said respondent voluntarily abandoned the bed and board of the complainant for more than two years immediately and continuously preceding the filing of this suit for divorce by the complainant; and that said abandonment was and is without cause, fault or consent on the part of the complainant; and that said complainant and respondent were living together as man and wife in Baldwin County, Alabama, at and preceding the time that the respondent abandoned the bed and board of the complainant.
- 5- That there are no living children by said marriage.

To the end that said respondent may show, if any reason there be, why the said complainant should not have the relief herein prayed for, may she be required to give a full, true and correct answer to each and allof the foregoing statements as if particularly interrogated as to each statement.

Your complaiant prays that the bonds of matrimony now existing between him and the said Mary Francis Hare may be dissolved and that the right may be granted your complainant to marry again.

Your complainant further prays that your Honor direct the Register of this Court to make out and superintend the proper order of publication to the said respondent, whose place of tesidence, whether in Alabama or not, is to the complainant unknown.

And your complainant will ever pray.
