WALLACE, whose name is to the Grand Jury otherwise unknown, did buy, receive, conceal, or aid in concealing one battery, of the value of, to-wit, eighteen dollars, the personal property of the State of Alabama, having reasonable grounds for believing it was stolen, and not having the intent to restore it to the owner, against the peace and dignity of the State of Alabama.
- 3. The Grand Jury of said County further charge that before the finding of this indictment R. G. WALLACE, whose name is to the Grand Jury otherwise unknown, did buy or receive one battery, of the value of, to-wit, eighteen dollars, the personal property of the State of Alabama, knowing that it had been embezzled or fraudulently converted, or fraudulently secreted with intent to prevent the recovery thereof, or to defraud the rightful owner,

against the peace and dignity of the State of Alabama.
