The deposition of Mattie S. Lowell and Kathryn M. Antoine, witnesses examined on behalf of the Complainant in the above entitled cause.

The said witnesses appeared before me at the time and place hereinafter named, and after having been first duly sworn by me to speak the truth, the whole truth, and nothing but the truth, did testify and say as follows:

KATHRYN M. ANTOINE.

I am the Complainant in this cause. I am thirty-one years of age and am now and have been all my life, a bona fide resident of the State of Alabama. For the last two years I have lived in Bay Minette, though I am at present employed in Mobile.

Angelo Antoine, the Defendant, is seven years older than I, and is also a life long resident of the State of Alabama. He too has been for the last few weeks employed in Mobile. He and I were married at Bay Minette, on April 29, 1919, and since that date up to about two years ago, lived in Mobile, but later returned to Bay Minette.

Several weeks ago when we came back to Mobile, he went to work for an Insurance Company, and later as a Salasman for an Automobile Company, and I, in the office of the Telephone Company. My husband, however, since We have been in Mobile, has done practically nothing for my support. In the latter part of October, I told him I could not support him, and if he could not support me, I could not live with him, but if he would go to work and make a living, I would return. He went away and stayed several nights, but kept coming back. About the twenty-sixth of October, I was sick and went out to the home of my sister, Mrs. W. J. Lowell, in the western part of the city of Mobile. He came out, and although he had promised

to stay away from me until he could do something for his own support as I had been paying for this myself.

On the night of November 3, 1928, he came by where I was working and came out with me to my sister's. He and I had an earnest talk, and I told him he was not keeping up to his agreement. tried to talk me out of this, but I insisted that he would have to do better. Mrs. Lowell left us talking in her living room, where I was lying on the davenport, but before she went to her room, she told Mr. Antoine that she had fixed a room for him. He and I talked awhile and then I fell asleep on the davenport, leaving him sitting up looking at the fire. I was suddenly awakened by a violent blow on my hip, and the cover which I had over me was dragged off. I think he had kicked me, for the next day I had a very bad bruise. He seemed to have flown into a sudden rage for he struck me several times on the side and arm, as well as in the face, calling out, "I am going to kill you," several times. screamed and he put his hand over my face, but about that time my sister ran in from her room and pulled him off of me, as he had me down on the davenport. He stopped when she came in and pulled him away, but he kept saying he was going to kill me. After my sister came, he did not strike me further, but kept making threats and saying that he would not mind seeing my blood all over the floor. Mrs. Lowell, my sister, tried to make him ashamed of himself, and made him get out out and told him to go home to his mother and tell her about all this and see what she would say about his conduct, and shortly afterward, he put on his hat and left. He has since then pretended to be very sorry, but as he had struck me on several previous occasions at Bay Minette, and would probably have killed me this time, had not my sister intervened, I would not listen to his requests for a reconciliation. I fear he would kill me some time in another fit of rage, in fact he has told other people that he was sorry he had not killed me on this occasion. As it was, he did me serious harm, I had livid black and blue spots on my arms and body and my nose bled at intervals for the next two days,

where he had struck me in the face. There is still a swollen place on my arm, nineteen days after I was struck.

I will not go back to live with him. He would not support me, nor even himself, and I fear he would kill me, if I stay with him.

MATTIE S. LOWELL

I am the older sister of the Complainant. I live in the western part of the city of Mobile. My sister and her husband have been life long residents of this State, and up to comparatively recently lived together apparently harmoniously.

They left Bay Minette a few weeks ago to look for work in Mobile, as Mr. Antoine was doing practically nothing there, and since they have been here, she has supported the pair of them. She has had to work ever since they were married in order to get a living. When she was sick in the latter part of October I had her come out to my house and then she told me that she was trying to make her husband stay away from her, because he would do nothing for their support. However, he kept coming out to the house, and I could understand that while she was sick, when she recovered she told him positively that he must leave, but he tried to talk her out of this Saturday night, November 3, 1928. I heard a part of the conversation, and left them in my living room still talking and arguing when I started to retire. I told him that he could have my son's room, my son being away that night, and my sister said that she would spend the night on the big davenport in the living room. My husband and grown daughter were away on that night. About an hour after I left them in the living room, I heard her screaming and calling my name. I ran into the living room and found him holding her down on the davenport, with his hand over her mouth and nose, she was struggling violently. I pulled him off of her and he seemed to come to himself somewhat, though he was still in a violent rage and walked up and down the room, threatening with every breath to kill her. Finding that he was utterly unreasonable,

and kept saying saying the same things over and over again, I told him that he must get out and leave the house before my husband returned from work, and I advised him to go to his own people. My sister was very much upset and excited and showed me her arms and body, where he had struck her. The next day she bore the marks of this, in livid bruises on her arms and body and with a swollen face. Her nose had fits of bleeding several times during the next two days as the result of the blows she had received.

I had never seen Mr. Antoine in a fit of rage before, but this time he seemed like a Mad man, and if I had not come, he would either have killed my sister or seriously injured her. He repeatedly said that he was going to kill her, and has told others since that he was sorry he did not finish the job that Saturday night.

In my opinion, it would dangerous for my sister to live with him, as from what I saw that night, he is a dangerous man, and would probably do her great harm.

He has never supported her since they have been married, and spends what money he makes on himself. Since they have been in Mobile this last time, she has entirely supported him.

TO THE HONORABLE JOHN D. LEIGH, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, SITTING IN EQUITY:

Comes Kathryn M. Antoine and by this her bill of complaint presented against Angelo C. Antoine, respectfully shows:

FIRST: That Complainant and Defendant are both over the age of twenty-one years; residents of the town of Bay Minette, Baldwin County.

<u>SECOND</u>: That Complainant and Defendant were married on April 29, 1919, at Bay Minette, and that since that date, lived in the city of Mobile up to about two years ago when they removed to Bay Minette, though both are at the present employed in the city of Mobile.

THIRD: That on the night of November 3, 1928, the Defendant without warning, tiew into a rage and assaulted and beat Complainant, striking her in the face and on her body with his fist, and was prevented from doing her further injury by Complainant's sister, who was sleeping in an adjoining room, and who hearing her sister's cries rushed in. That Defendant has on several previous occasions threatened Complainant with bodily harm, and on this occasion, stated in the presence of Complainant's sister that he was sorry that he had not killed her as he had intended to do, and which he expected to do in the future. Complainant avers that he had several times previous struck her, but had not gone to such lengths as on the occasion here described. Complainant further fears that if she continued to live with him, the Defendant would carry out his threats, and if he did not kill her, would do her serious bodily harm. From the effects of the blows, she had livid bruises on her arms and body, and recurrent fits of nose-bleeding the following day from the blows received in her face. Since November 3, 1928, Complainant has lived entirely separate and apart from the Defendant, and has not resumed marital relations with him in any way.

THE PREMISES CONSIDERED, Complainant prays that Angelo C.

Antoine be made party defendant to this cause and required to answer this bill within the time prescribed by law.
