To the Honorable John D. Leigh, Judge of the 21st Judicial Circuit:

Your complainant, Angie L. Green respectfully represents that she is a bona fide resident of Baldwin County, Alabama, and has been such resident for more than one year next preceding the filing of this bill, and that she is over the age of 21 years, and that defendant, Henry F. Green is a non-resident of the State of Alabama, and when last heard from him, he was in Los Angeles, California, and he over the age of 21 years.

Second.

June 6,

That on to-wit:- ~~October~~ 1915 your complainant was married to defendant, and they lived together as man and wife until October 1925.

Third.

That on or about October 16, 1925, and prior and subsequent thereto, defendant, Henry F. Green beat, bruised and threatened the life of complainant, and on one of these occasions he broke the nose of complainant, and this actual violence on her person was attended with danger to life and health, and from his acts of violence she feared for her life, if she lived with him longer.

Fourth.

That as the result of said marriage there were born to complainant and defendant, ~~four~~ <sup>three</sup> children,- Henry Green, aged eight years; Marilyn Green, age, 6 years and Cloyd Green age 5 years, and complainant asks that she may still have the custody and care of these children, as she is well able financially and morally to raise and care for said children, and defendant is not a proper person to have the care and custody of said children. Premises considered complainant prays that defendant, Henry F. Green be made a party to this cause by publication as required by law, and that after service is had on him by publication, and upon a final hearing your honor will grant complainant a decree of absolute divorce from the said Henry F. Green, and permission to marry again, and also award to complainant, the custody of the above named children, and such other and further relief may be granted to complainant as your honor may deem proper.

Mrs. Angie L. Green, the Complainant, who being duly sworn

doth depose and say as follows:-

My name is Angie L. Green; I am the Complainant in this cause; I have been a bona fide resident of Baldwin County, Alabama for more than twelve months next preceeding the filing of this Bill of Complaint, and I am over the age of twenty-one years.

Defendant Henry F. Green is a non-resident of the State of Alabama, and when last heard from resided at Los Angeles, California, and he is over the age of twenty-one years.

On June 6th., 1925, I was married to Defendant and we lived together as man and wife until October, 1925. On or about October 15th., 1925, and on several occasions previous to that the Defendant and Henry F. Green beat and bruised me and threatened my life, and he broke my nose and broke one of my ribs and this actual violence on his part on my person was attended with danger to my life and health, and from his acts of violence and threats on my life I was in great fear of being killed so that I considered that my life was in great danger if I lived any longer with him.

As a result of this marriage there were born to Complainant and Henry F. Green the Defendant, three children, viz:- Henry

..Green, age eight years, Marilyn Green age six years, Cloyd Green age five years. These three children are now in the custody and control of their Mother Mrs. Angie L.Green, the Complainant in this cause. Henry F.Green is not a competent person to raise and have the custody of these children and Mrs. Angie L.Green is both morally and financially able and competent to raise and care for these children and she asks that she be allowed to retain the custody, care and possession and control of these children,

..... I always made my husband a good wife and treated him in every way as a wife should treat her husband and gave him no cause whatever for his acts of cruelty and violence to my person and he never had any cause whatever to mistreat me in any way.

..... Mrs. Grace L. Myers, witness for the Complainant, who being duly sworn testified as follows:-

..... My name is Mrs. Grace L. Myers; Mrs. Angie L.Green is my niece; I lived with Mrs. Green and her husband parts of the last five years of their married life. During the time I lived with them I had occasion to observe the conduct of Mr. Green. And Mr. Henry F.Green was frequently brutal and treated his wife, Mrs. Angie L.Green in a cruel and inhuman manner. I saw him, Mr. Green strike her frequently and threatened to commit serious bodily injury on her person and I admonished him at the time. At one time during that period <sup>he</sup> struck her. I considered my niece, Mrs. Angie L.Green in danger constantly.

..... Mrs. Green is fully capable of taking care of her three children, Henry H., Marilyn, and Cloyd as she has done so for the past several years and they are now capably and well cared for. I do not consider that Mr. Henry F.Green is in any wise competent or capable of taking care of properly educating and raising aforesaid children

..... Mrs. Green was always a kind and considerate wife and performed her duties as such.

..... Both Angie L.Green and Henry F.Green are over the age of twenty-one years.
