And that Your Honor forthwith set same downfor hearing and trial, not less than three days from date of the Solicitor filing said charge; and that on said date of hearing, Your Honor hear and determine your petitioner's plea of guilty, and fix your petitioner's punishment and forthwith sentence your petitioner to the penitentiary of the State of Alabama. And he prays for general relief.
