Statement of Dillion Ray Pittman, Driver of Private Chevrolet Panel Truck, in Regard to Collision of this Truck and Chevrolet Panel Truck, USED No. 1875 on Novomber 7, 1942.

I was proceeding east on highway No. 31 at about 30 miles per hour following about 100 feet behind another car, and suddenly this car stopped on the highway without any hand signal -- I don't remember seeing his stop light. I was unable to stop to avoid striking the car in front of me and as it looked like a pretty deep ditch to the right of me. I swung to my left to evoid hitting this car in front of me. As soon as I sew the car in front of me stopping, I applied my brakes and kept them applied until the collision.

I didn't see the lights of the approaching Government car as the car shead of me was near the center line and blocked my view. We must have been about 50 to 75 feet apart when I first saw the Government car.

Passengers in my car were Freeman Pittman, Lulu Henderson-7 years old, Doodle Bloodsworth, besides my self. My upper lip was torn loose from gum and badly cut, my father suffered cuts and bruises about the head and face.

The driver of the Government car had his headlights on.
