APPEAL BOND

STATE OF ALABAMA

BALDWIN COUNTY

KNOW ALL MEN BY THESE PRESENTS: That whereas, the undersigned Principal, Bert Powell, was on the 3rd day of January 1944 convicted in the Justice Court of C. C. Hand, Justice of Peace, Precinct 4, Baldwin County, Alabama, of the offense of

Hunting on lands of another without permit; and

WHEREAS, the said Bert Powell has appealed from the said conviction to the Circuit Court of Baldwin County, Alabama, and does hereby demand a jury trial of the said cause:

NOW THEREFORE, We, Bert Powell, as Principal and the undersigned as sureties agree to pay to the State of Alabama the sum of Two Hundred Dollars (\$200.00) unless the said Bert Powell shall appear at the Spring 1944 term of the Circuit Court of Baldwin County, Alabama and from term to term thereafter until discharged by law, to answer a criminal prosecution for the offense of Hunting on lands of another without permit. We hereby waive as to all amounts that may become due hereunder, the benefits of all laws exempting personal property from levy and sale under execution or other process for the collection of the debt by the Constitution or laws of the State of Alabama and we hereby severally certify that we have property over and above all debts, liabilities and exemption and this bond to the amount of: Real property of the value of \$2,000.00 and personal property of \$1,000.00.
