Richerson, as Register and Commissioner, have called and caused to come before me, Margaret Sanford and Susie Slavick, Witnesses named in the Requirement for Oral Examination, on the Good day of October, 1929, at my office in the Court House, Bay Minette, Alabama, and having first sworn said witnesses to speak the truth, the whole truth and nothing but the truth, the said Margaret Sanford doth depose and say as follows:

My name is Margaret Sanford; I am the plaintiff in this action for divorce against William A. Sanford and was married to him in Worcester, Massachusetts on February 14th, 1925. We lived together there until after my baby, Francis Sanford, was born, which was in March, 1926. The baby did not do well and when she was three months old my husband and I decided that I should take my baby and go home to my mother's for a visit and to see if the baby would do better in the country. My father and mother have lived in Baldwin County, Alabama, near Miflin, for about thirteen years. My husband, the defendant, was supposed to work and send us money to live on and come home on, but after I had been here a weeks few manths the baby improved so that we decided my husband should come here also, as my father had a farm he was willing to give us the use of and as my husband could not make enough money up north to keep us anyway.

He came to Baldwin County about the first of July, 1926, but he did not care to farm, in fact did not seem to care to work at all, and my folks had to support all of us. He went to Pensacola and got a job there but only kept it a short while when he decided to go back north and get work and to send for the baby and me when he got a job.

was supposed to go to work there and send for his wife and baby, at least that is what he said he was going to do, but he never did send for them. He kept writing to her trying to get her to borrow money from her father but her father could not lend them any and he never even wrote another letter after she told him she could not borrow the money. He has not written to her for more than two years and has not lived with her or sent herany money for herself or the baby for two and a half years. He never did intend to send for her at all, I think, but just ran off and left her with the baby to take care of. I do not know where he is and my daughter does not know either.

She never gave him any cause to leave her but was always a good wife and a good mother to the baby and she has always taken good care of the baby.

He wrote me a few letters, trying to get me to borrow money from my parents but when I told him that they were not willing to lend us any money, he quit writing altogether and all I have not heard from him at/since. The last I heard from him was in June, 1927 and he has not even written a letter to me since that time. He has abandoned the baby and me and has not provided one cent for our support for more than three years and I do not now know where he is nor anything at all about him. He never did support us and always drank so that practically all he could earn was spent for liquor, and it has been more than two years since he left me and we have not lived together since. I was always as good a wife to him as I could be and gave him no cause at all to leave me and the baby.

I have been a resident of Baldwin County, Alabama, since June 1926 and for more than three years before filing this bill for divorce, and it is my intention to make Baldwin County, Alabama, my permanent home. I am able to support and educate my baby Francis Sanford, and desire that the Court give me the exclusive custody of her, as her father, the defendant, is not a fit person to have the care and custody of any child.
