The Condition of the above obligation is such, That, whereas, the above bounden Lorena Burkett was, on the 21 day of Dec 1934 convicted in the Justice Court, Baldwin County, of the offense Assault

and by the judgment of said Court sentenced to Pay fine of 20.00 & Costs
or to serve 30 days in Baldwin Co Jail

And, whereas, the said Lorena Burkett has this day prayed an appeal from said judgment to the Circuit Court of said County:

Now, if the said Lorena Burkett shall appear at the next term of the Circuit Court, and from term to term thereafter until discharged, and abide by and perform whatever sentence may be adjudged in said Court against him, then the above obligation to be void; otherwise to remain in full force and effect.
