Said that he heard Ernie Davis say to Douglas Catrett, that he had a gun and that he would blow a hole in him. Just before the shooting.

#### A.R.Cromartie-

Said he heard Earnie Davis say to Douglas Catrett \* I know you have a gun\_ I have one toomlay your gun down and ISI1 lay mine down and we will fight

it out fair and that if you make a move ISIL blow a hole through you-Also that he hear Davis curse Catrett not understand the identical words. J.H. Ford;

Said that he heard Earnie Davis say to Douglas Catrett \*If you will step out I will whip you. If you move that car I will blow a hole in it \*Also that he heard Davis curse Catrett, not knowing the exact words used. And that Catrett said to Davis \*You had better go on \* the only words he heard Catrett speak. Shooting following immediately the cursing by Davis, James Mc Donald;

Was driver or Taxi on afternoon of killing-Davis and wife as passengers in his car - passed car in which Douglas Catrett was rifing-and that Davis asked him to slow down and as he passes the car in which Catrett was riding that Davis held out his hand to him to stop-but that he didnt stop-and that just as they reached along about Third Street-in Bay Minette-that Catrett turned his car around and met them as he Catrett was headed back toward Stockton; having passed them where the slowed down and tried to flag gatrett to a stop.

Mrs. Lucy GreekRelated to both parties; said she heard Douglas Catrett say that "I'm
going to kill that son of a bitch (meaning Earnie Davis) on sight. That
he came back about eleven oclock that night-had the rifle-and waited
along the road side where Davis was supposed to pass. Had also heard
threats by Davis against Catrett;-

Chas. Byrd;
Saw open pearl handled knife at top edge of Davis left shoulder-after he was shot, and lying on his back in street-Saw no gun- was first to Davis.

J.L.Barrow-

Picked up knife-open- from under Davis's left shoulder-Ed Stanton-

Said he had known Catrett for 12 years-hunted and trapped and fished with him-and that Catrett carried his rifle with him most all of the time; in his boat or automobile.

Owen Hammond-

said he had sold gas to Catrett for three or four years and that he saw his rifle in his car often.
