TO THE HONORABLE F. W. HARE, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, IN EQUITY.

Comes your complainant Dave Dentis and humbly complaining against Carrie Dentis, the defendant, respectfully represents and shows unto your Honor as follows:

FIRST:

That both your complainant and the defendant are residents of Baldwin County, Alabama, over twenty-one years of age, and have been residents for more than three years next preceding the filing of this bill of complaint.

SECOND:

That your complainant and the defendant are husband and wife, having intermarried at Bay Minette, Baldwin County, Alabama, on to-wit, December 8, 1928.

THIRD:

That on to-wit, in March, 1929, the defendant committed acts of adultery with one _______, that said acts of adultery were committed in Baldwin County, Alabama, without the consent or approval of the complainant, and that the complainant has not condoned said acts of adultery.

Wherefore the premises considered the complainant prays that your Honor will, by proper process, make the said Carrie Dentis party defendant to this bill of complaint, requiring her to plead, answer or demur to the same within the time and under the penalties prescribed by law and the practice of this Honorable Court.

The complainant further prays that upon a final hearing of this cause your Honor will enter an order and decree forever barring the bonds of matrimony existing between him and the said defendant, and that your Honor will give and grant unto him such

other, further, different or general relief as he may be in equity and good conscience entitled to receive, and as in duty bound he will ever pray.


