and by the judgment of said Court sentenced to \$10000 Fine  
and cost

And, whereas, the said Willie Adams has this day prayed an appeal from said judgment to the Circuit Court of said County:

Now, if the said Willie Adams shall appear at the next term of the Circuit Court, and from term to term thereafter until discharged, and abide by and perform whatever sentence may be adjudged in said Court against him, then the above obligation to be void, otherwise to remain in full force and effect.
