IN THE JUVENILE COURT OF BALDWIN COUNTY, ALABAMA:

The above cause was first heard in the Honorable Court of Chas. C. Hand, Justice of the Peace, Beat Four, Baldwin County, Alabama, on a charge against said Arthur Milstead and Lonnie Milstead of assault with intent to murder, and upon the hearing of the testimony in said Court the said Chas. C. Hand as Justice of the Feace of Beat Four, Bay Minette, Baldwin County, Alabama, finding that the said Defendants, Arthur Milstead and Lonnie Milstead, were minors over fourteen and under eighteen years of age, transferred the said cause and the Defendants, Arthur Milstead and Lonnie Milstead and Lonnie Milstead to this Court.

Hall as Deputy Solicitor for Baldwin County, Alabama, upon the original warrant sworn out in the Justice of the Peace Court of Mon. Chas. C. Hand, the return of the Sheriff thereon, and the order of the said Mon. Chas. C. Hand, Justice of the Peace, transferring the cause and the Defendants to this Court; and after having first heard the testimony for the State and forthe Defendants, Arthur Milstead and Lonnie Lilstead, the Court is satisfied that the said Arthur Milstead is a minor over sixteen and under eighteen years of age, and the said Lonnie Milstead is a minor over fourteen and under sixteen years of age;

And it is the further opinion, and the Court is convinced that the said Arthur Milstead and Lonnie Milstead, minors over fourteen and under eighteen years of age, cannot be made to lead a correct life and cannot be properly disciplined under the provisions of the laws of the State of Alabama governing juvenile delinquents;

IT IS THEREFORE CRDERED, ADJUDGED AND DECREED that the said cause of the State of Alabama, vs Arthur Milstead and Lonnie Milstead, and the said Arthur Milstead and Lonnie Milstead be remanded to the Hon. Court of Chas. C. Hand, Justice of the Peace, Beat four, Bay Minette, Baldwin County, Alabama, there to be proceeded against according to law;

And the said Arthur Hilstead and Lonnie Milstead, acting by and through their attorney, N. C. Stone, giving notice of an appeal to the Circuit Court of Baldwin County, Alabama, sitting as a Court of Equity; IT IS THERETORE ORDERED, ADJUDGED AND DECREED that said Arthur Milstead and Lonnie Milstead be committed to the County Jail pending their making bail in the sum of Seven Hundred Fifty Dollars each, with good and sufficient sureties, to answer such proceedings in the Court to which this said cause and the Defendants, Arthur Milstead and Lonnie Milstead have been transferred.
