We, Carnis Lassiter/and the undersigned as sureties, agree to pay to the State of Alabama the sum of Twenty-Five Hundred Dollars (\$2500.00), unless the said Carnis Lassiter appears at the next term of the Circuit Court of Baldwin County, and from term to term thereafter until discharged by law, to answer a criminal prosecution for the offense of manslaughter in the first degree.

And we, and each of us, hereby waive all exemptions we may have to any personal property under the Consitution and Laws of the State of Alabama as to the collection of the penalty of this bond.

The condition of the above obligation is such that, whereas the above bound Carnis Lassiter was duly convicted in the Circuit Court of Baldwin County on the 7th day of April, 1949, of the above stated offense, and has duly applied for and obtained an appeal from said conviction and sentence to the Court of Appeals for the State of Alabama, and the amount of his appeal bond has been duly and legally fixed at said above stated sum:

Now therefore, if the said Carnis Lassiter shall appear at the next term of the Circuit Court of Baldwin County, and from term to term thereafter until discharged by law, and abide the judgment of the said Court of Appeals for the State of Alabama, then this obligation to be void and of no effect; otherwise to remain in full force and effect.
