

My wife i s an unfit person to have the care, custody and control. of said children , and is incapable of properly raising them,

My name is F.B.Gardner, I reside at Daphne Baldwin County, Ala, and know James E Keith and his wife Sybul S.Keith, I also know, J.A.Dean, Both are over the age of 21 years. On one occasion about the month of Febuary 1950, I saw J.A.Dean and the defendant Sybul S.Keith in bed together with nothing but their night gowns on, this was at the home of James E.Keith, who was absent from home running on the Boat as an Engineeer, from Magnolia Springs to Mobile, on a number of occassions I have seen the defendant at the store in which J.A.Dean worked near Barnewell, and on one occassion, I saw J.A.Dean, carry the defendant in his arms from the Automobile into the store,

On one occassion the defendant and one Morgan welson, having sexual intercourse on the ground in the woods in my opinion the defendant is an unfit person to have the care custody and control of their children, and James E.Keith is fully competent and capable of raising them in the proper manner,

All during the time I have known the Complainant and the Defenant he has been a dutifu 1 , Considerate , husband and father, and I know of no cause of complaint against him .
