STATE OF ALABAMA VS. FRED CALVERT

ON APPEAL FROM JUSTICE COURT, PRECINCT # 8, BALDWIN COUNTY, ALABAMA.

- I. The State of Alabama, by its Solicitor, complains of Fred Calvert, whose name is to your informant otherwise unknown than as stated, that in said County and within twelve months before the commencement of this prosecution he did haul, transport, or convey liquefied gas upon U. S. Highway 31, a public highway of the State of Alabama, in Baldwin County, Alabama, in a vehicle, other than a railroad car, which was then and there transporting liquefied gas in excess of five gallong not used exclusively for propelling the said vehicle, the said vehicle not being plainly and visibly marked on each side and on the rear of said vehicle with the name and address of the owner of the vehicle in which the said liquefied gas was then and there contained, contrary to law and against the peace and dignity of the State of Alabama.
- Calvert, whose name is to your informant otherwise unknown than as stated, that in said County and within twelve months before the commencement of this prosecution he did haul, transport, or convey liquefied gas in a vehicle other than a railroad car, which was then and there transporting liquefied gas in excess of five gallons not used exclusively for propelling the said vehicle, over and upon U. S. Highwa 31, a public highway of the State of Alabama, in Baldwin County, Alabama, without then and there having in his possession an invoice, or bill of sale, or other record evidence showing the true name and address of the person from whom he had received said liquefied gas, contrary to law and against the peace and dignity of the State of Alabama.
