

INDICTMENT

THE STATE OF ALABAMA }
Baldwin County. } Circuit Court, Fall Session, 1951

The Grand Jury of said County charge that before the finding of this indictment Olanda Barnes, Alias Orlando Barnes, alias Landa Barnes, whose name is to the Grand Jury otherwise unknown than as stated, feloniously took and carried away, to-wit Seventy Dollars in lawful United States currency, in ten dollar bills, five dollar bills, and one dollar bills, the number of each of said denominations being unknown to the Grand Jury, and the denominations and description of said currency being to the Grand Jury otherwise unknown, and, to-wit, five dollars in specie coin of the United States, the denomination and description of said coin being to the Grand Jury unknown, of the value of, to-wit, seventy-five dollars, the personal property of Leoda McWilliams, against the peace and dignity of the State of Alabama.

2. The Grand Jury of said County further charge that before the finding of this indictment, Olanda Barnes, alias Orlando Barnes, alias Landa Barnes, whose name is to the Grand Jury otherwise unknown than as stated, did buy, receive conceal, or aid in concealing, to-wit, Seventy Dollars in lawful United States Currency, in ten dollar bills, five dollar bills, and one dollar bills, the number of each of said denominations being unknown to the Grand Jury, and the denomination and description of said currency being to the Grand Jury otherwise unknown, and, to-wit, five dollars in specie coin of the United States, the denomination and description of said coin being to the Grand Jury unknown, of the value of, to-wit, Seventy Five Dollars, the personal property of Leoda McWilliams, knowing that the said property was stolen, or having reasonable grounds for believing that it was stolen, and not having the intent to restore it to the owner,

against the peace and dignity of the State of Alabama.
