## THE STATE OF ALABAMA Baldwin County.

Circuit Court, Spring Session, 1952

- I. The Grand Jury of said County charge that before the finding of this indictment Ester Mitchell, whose name is to the Grand Jury otherwise unknown, did, while in an intoxicated condition, drive a motor vehicle on U.S. Highway 31, a public highway, in Baldwin County, Alabama, against the peace and dignity of the State of Alabama.

The Grand Jury of said County charge that before the finding of this indictment Ester Mitchell, whose name is to the Grand Jury otherwise unknown, did, while under the influence of intoxicating beverages or drugs, drive a motor vehicle upon U.S. Highway 31, a public highway, in Baldwin County, Alabama,

against the peace and dignity of the State of Alabama.
