The Grand Jury of said County further charge that before the finding of this indictment FLORENCE HINES, alial FLORENCE HINOTE, alias ETTA COSLAR, whose name is to the Grand Jury otherwise unknown, unlawfully, and with malice aforethought, killed Leslie Gee, by some means to the Grand Jury unknown,

against the peace and dignity of the State of Alabama.
