MIDDLETON, whose name is to the Grand Jury otherwise unknown, feloniously took and carried away from the storehouse of Pat Brock, Mattie Rose Brock and Alfred Mosley, to-wit, fourteen dollars in United States Silver and copper coin, the number of each of sail denomination and a further description of the denominations being unknown to the Grand Jury, of the value of, to-wit, fourteen dollars, the personal property of Pat Brock, Mattie Rose Brock and Alfred Mosley,

against the peace and dignity of the State of Alabama.
