Highway 31, issued by the Director of Public Safety and the Highway Director of Alabama, and approved by the Governor of Alabama, under the authority of Section 3 of Act number 516, General Acts of Alabama of 1949, page 740, against the peace and dignity of the State of Alabama.

2. The Grand Jury of said County further charge that before the finding of this indictment CURTIS E. McGHEE, whose name is to the Grand Jury otherwise unknown, did operate a motor vehicle on a public highway of this state, being, to-wit, U. S. Highway 31, in Faldwin County, Alahama, at a rate of speed that was greater than was reasonable and proper, having regard to the traffic and use of said highway, or so as to endanger property or the life and limb of persons, to-wit, rate of at a/speed of seventy-five miles per hour,

against the peace and dignity of the State of Alabama.
