has this day prayed an appeal from said judgement to the Circuit Court of said County:

Now, if the said Mrs. McLeod Crenshaw shall appear at the next term of the Circuit Court, and from term to term thereafter until discharged, and abide by and perform whatever sentence may be adjudged in said Court against him, then the above obligation to be void, otherwise to remain in full force and effect.
