On February 4, 1958, at 12:45 PM, Allen Woodrow Wilson, Hubert Huey Ardis and Curtis Hurd operated an illicit distillery at a point approximately twenty-nine (29) miles south of Bay Minette, Baldwin County, Alabama. Wilson was arrested at the distillery. Ardis and Hurd escaped and a State warrant was issued for their arrest. Wilson declined to make a written statement.

On February 4, 1958, I accompanied A&TT Investigators Zoran Konda, Peter Willemoes and Richard H. Dickinson; and ABC Agent Albert McDonald to the vicinity of a previously located distillery. Dickinson and I were to make the initial raid down the still path with the remaining officers to get opposite us to receive any violators who ran.

As Dickinson and I approached the still, I saw a young white male make a trip to some bushes and carry a bulky object toward the still. At about 12:45 PM, I went to a point about twenty feet from the still. There I saw a colored male working among the mash barrels; a young white male walking in the still yard and an older white male working around the condenser spout. The young white male started out the still trail with a burlap bag in his hand and saw us. He ran through the still yard and the other workers joined him in flight. Allen Wilson was arrested and brought to the still. He stated the young white male who escaped was Hubert Ardis and the colored male was Curtis Hurd.

I examined the still and found it to be a 633 gallon pot still, 30-60 gallon fermenters containing 1,351 gallons mash, complete and in operation with 73 gallons non-taxpaid distilled spirits. Wilson stated to me this was the third operation of the still and he was receiving \$1.00 per barrel for assisting in operating it. He stated he did not know who owned the operation but Hubert Ardis had hired him.

The distillery and equipment was destroyed. Allen Wilson was placed in Baldwin County Jail, Bay Minette, Alabama pending prosecution in state court. State arrests warrant were issued for Hubert Ardis and Curtis Hurd. On February 8, 1958, at Pensacola, Florida, I viewed Curtis Hurd, and identify him as being the colored male who escaped from the still.

Wilson declined to give a written statement.

This report relates to the seizure of an illicit distillery located in open woods about 29 miles south/east of Bay Minette, Baldwin County, Alabama; The arrest of Allen Woodrow Wilson, General Delivery, Gonzales Florida, complaint filed and warrants of arrest issued for Curtis Hurd, Pensacola Florida, and Hubert Haey Ardis, address unknown.

On February 4, 1958, I accompanied A&TT Investigators Louis F. Fisher, Richard Dickinson, Peter Willemoes and ABC. Agent A.C. McDonald to a point about 29 miles south/east of Bay Minette in Baldwin County, Alabama, to the site of an illicit distillery.

Approaching the still site on foot I saw a white man walking on the still path going away from the still, I then went above the still to act as reciever, I then heard the still being raided but no violators came my direction. I returned to the still and saw Wilson in custody, Wilson stated in my presence that he was hired to operate the still by ~~an~~ Hubert Ardis, who was at the still and escaped along with a colored male known as Curtis who lived in Pensacola Florida, further investigation revealed this to be one Curtis Hurd. Wilson also stated that this was the third time that he had operated the still and that he was hired just to run the still and had no interest in it whatsoever, he was paid one dollar per barrel of mash.

The distillery consisted of one 633 gallon pot still with copper vapor lines and a double wall condenser in a cooling tank; 30 60-gallon durm fermenters; 1351 gallons of fermented mash; 73 gallons of whiskey; 37 five gallon glass jugs; 1-30 gallon pressure tank with oil burner; 1320 pounds of wet sugar and miscellaneous minor equipment. I assisted in searching the woods in an attempt to apprehend the two violators that had excaped, but with no success.

The distillery was destroyed and the whiskey was dumped at the place of seizure. Wilson was placed in the Baldwin County jail at Bay Minette Alabama, for action in state court. Wilson freely admitted his actions in the violation but declined to sign a statement. On February 5, 1958, complaints were filed against H.H. Ardis and Curtis Hurd before Justice of the Peace T.C. Hand, Bay Minette, Alabama, and warrants of arrest were issued the same date.

On February 4, 1958 I assisted A&TT Investigators Louis F. Fisher, Zoran Konda, and Richard H. Dickinson, and ABC Agent A.C. McDonald in an investigation of a violation of the Internal Revenue Laws and the State liquor laws at a point twenty-nine miles South of Bay Minette, Baldwin County, Alabama. This investigation resulted in the seizure and destruction of an unregistered distillery consisting of 1-633 gallon pot still, complete and set up with one condensor, 30-60 gallon fermenting drums, 1,351 gallons fermenting mash, 73 gallons non-taxpaid whiskey, 1,320 pounds damaged (wet) sugar, 8-5 gallon cans, 35 gallons fuel oil, 1-30 gallon pressure fuel tank, lines and burners, 37-5 gallon jugs, 1 tire pump, 1 monkey wrench, 2 shovels, 1 hatchet, 1 hoe, 2 funnels, 50 feet of 3 inch hose, 30 feet 1 inch hose, and 1 hammer. Allen Woodrow Wilson, General Delivery, Gonzales, Florida was arrested in connection with the violation. State arrest warrants were issued on February 5, 1958 for Hubert Huey Ardis, address unknown, and Curtis Hurd, Pensacola, Florida in connection with this violation.

On February 4, 1958 at 12:45 PM I observed the subject distillery. I saw an unidentified white man working at the catch bucket-catching whiskey. I also saw an unidentified negro male working on the opposite side of the still yard. At this time the still was raided. I saw Investigator Dickinson arrest Allen Woodrow Wilson, white male. The other white man and the negro man escaped.

Wilson stated to me that the white man was Hubert Ardis and that the negro man had the first name of Curtis and that he didn't know his last name but that he knew exactly where Curtis lived. Wilson then described how to get to the place where Curtis lived. A check with authorities in Pensacola revealed that Curtis Hurd, negro male, lived at the residence described. State arrest warrants were issued against Curtis Hurd and Hubert Huey Ardis. Prosecution is to be in Baldwin County, Alabama.

Wilson was left in the custody of the Sheriff, Baldwin County, Alabama, for prosecution in that County. Wilson declined to sign a written statement.

This report relates to the seizure of one (1) 633 gallon box-type still; 1351 gallons of sugar & rye mash; thirty (30) 60 gallon fermenters; 73 gallons of non-taxpaid whiskey; 1320 pounds of damaged (wet) sugar; one (1) complete cooling system, consisting of hollow wall condenser and vapor lines; one (1) 30 gallon pressure fuel tank, complete with copper lines and burner; 35 gallons of fuel oil; eight (8) 5 gallon cans; thirty-seven (37) 5 gallon jugs; one (1) tire pump; one (1) monkey wrench; two (2) shovels; one (1) hatchet; one (1) hoe; two (2) funnels; 50 feet of 3 inch hose; 30 feet of 1 inch hose; and one (1) hammer. Allen Woodrow Wilson, white male, was arrested at the still site; State arrest warrants were issued on February 5, 1958, for Hubert Huey Ardis, white male, address unknown, and Curtis Hurd, colored male, Pensacola, Florida, in connection with this violation. This arrest and seizure occurred at a point approximately 29 miles southeast of Bay Minette, Baldwin County, Alabama. Officers participating in this case were: Louis F. Fisher, A&TT, Mobile, Alabama; Zoran Konda, A&TT, Mobile, Alabama; Peter Willemoes, A&TT, Mobile, Alabama; A. C. McDonald, State ABC Agent, Bay Minette, Alabama, and myself.

On February 4, 1958, I assisted the above officers on a still investigation and seizure, at the above point, in an effort to obtain Raw Materials information and apprehend violators. I, along with Investigator Fisher, was assigned to raid the subject distillery. In approaching the still path, I observed an unknown young white boy come out the still path and go to a point off the still path and carry hidden materials back to the still. Investigator Fisher and I then went down the still path behind the white boy to make the raid. Upon reaching approximately twenty feet from the still, I observed the same white boy working at the still, along with another older white man and an unknown colored male. The white boy continued working approximately four minutes and then came out the main still path and walked out to approximately ten feet from Fisher and me and then saw us lying in the the still path and turned and fled back through the still yard, at the same time giving an alarm. I ran through the still yard and across the creek chasing both white men. I apprehended the older white man and questioned him as to the identity of the other two who had fled. He stated his own name as Allen Woodrow Wilson and stated that the white boy who escaped was Hubert Ardis, who had hired him to cook at the still and the colored man was Curtis Hurd, Pensacola, Florida. Wilson stated that this was the third time he had run the still and was receiving one dollar per barrel for running.

The complete distillery was destroyed, along with the whiskey, at the time and place of seizure. On February 5, 1958, complaints were filed for the apprehension of Hubert Ardis and Curtis Hurd before Justice of the Peace T. C. Hand, Bay Minette, Alabama, and warrants of arrest were issued the same date. This is to be a state prosecuted case.

On the morning of February 4, 1958, I accompanied A&T Investigators Louis F. Fisher, Richard Dickinson, Peter Willemoes and Zoran Konda to a point about 29 miles south/east of Bay Minette in Baldwin County Alabama, to the site of an illicit distillery in open woods.

Approaching the still on foot I saw a white male on the still path that I recognized as Hubert Ardis, he was on the path going away from the still, I then went above the still and concealed myself and waited for Fisher and Dickinson to raid. I heard them raid and no violators came my way. I then returned to the still site and saw Allen Woodrow Wilson under arrest.

The distillery consisted of 1-633 Gallon box still with copper steam lines and double wall condenser; 30-60 gallon drum fermenters containing about 1351 gallons of fermented mash; 37 five gallon glass jugs; 73 gallons of whiskey; 1320 pounds of sugar; one pressure tank with burner.

Wilson stated in my presence that he was hired to operate the still by Ardis, that Ardis came to his house one night and hired him to run the still for one dollar a barrel, he said that this was the third time that he had run the still and that Ardis and a colored man known only by the name of Curtis helped him at the still.

The distillery was destroyed, Wilson was taken to the Baldwin County jail and was detained pending action in state court. I filed a complaint with Justice of the Peace T.C. Hand in Bay Minette on 2/5/58 and warrants of arrest were issued for Hubert Ardis and Curtis Hurd.

stated as follows:


I am L.F. Dantzler. I am Area Forrest Superintendent for this area.
