convicted in the Municipal Court of the said City of Foley, of the

And, Whereas, the said Eula Mae Barnett
has this day prayed on appeal from said Judgement to the Circuit Court
of said County.

NOW, if the said Eula Mae Barnett
shall appear at the next term of the Circuit Court, and from term to
term thereafter until discharged, and abide by and perform whatever
sentence may be adjudged in said Court against him, then the above
obligation is to be void; otherwise to remain in full force and effect;
and each of us to waive our exemptions as to personal property.
