Wait to be thrown into, against, upon, or from the said automobile in which he, the said C. H. Wait, was operating, against the peace and dignity of the State of Alabama.

COUNT 2.

The Grand Jury of said County further charge that before the finding of this indictment, Richard Wells, whose name is to the Grand Jury otherwise unknown, unlawfully, but without malice, of the intention to kill, killed C. H. Wait by running into or against an automobile in which the said C. H. Wait was riding, with a motor automobile,

against the peace and dignity of the State of Alabama.

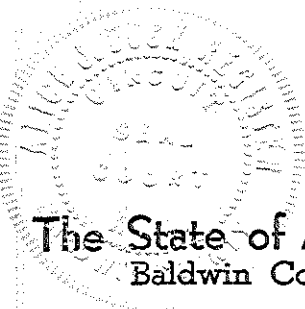
