Before me, the undersigned authority in and for said State and County, this day personally appeared COY MIXON, who is known to me and who having been by me first duly sworn, deposes and says that his name is Coy Mixon; that he is a bona fide resident of Bay Minette, Baldwin County, Alabama, over twenty-one years of age; that the respondent, O. C. Hall, is over twenty-one years and a resident of Bay Minette, Baldwin County, Alabama; that on April 19, 1930, his mother filed her bill in the Circuit Court of Baldwin County, Alabama, asking that a Trustee be appointed for preserving or protecting his estate against waste, alleging that he was by reason of intemperance wasting or squandering his estate, and thereby in danger of being reduced to poverty and want; that on June 27, 1930, a final decree was rendered appointing O. C. Hall of Bay Minette, Alabama, as Trustee; that on July 5, 1930, the said O. C. Hall filed his bond and which bond was on said date taken and approved by the Register of the Court.

That his estate has since July 5, 1930, and up until this time been handled by the said O. C. Hall, as Trustee; that he at that time had coming to him from the United States Government as insurance benefits the sum of Seven Thousand Seven Hundred Sixty-two and 50/100 Dollars (\$7,762.50), which amount was paid over to the said O. C. Hall, as Trustee; that in addition to this amount the said O. C. Hall, as Trustee, has monthly received as Trustee for him something in the aggregate of One Hundred Thirty-three and 50/100 Dollars (\$133.50) up until just

recently, when the award was increased to One Hundred Fifty-seven and 50/100 Dollars (\$157.50).

That up until January 15, 1932, the said O. C. Hall, as Trustee, had received for him the total amount of Eleven Thousand Two Hundred Twenty-eight and 01/100 Dollars (\$11,228.01) and had disbursed Ten Thousand Nine Hundred Fifty-six and 91/100 Dollars (\$10,956.91), leaving a balance of Two Hundred Seventy-one and 10/100 Dollars (\$271.10), which amount was on deposit in the Baldwin County Bank at the time its doors closed on January 27, 1932, and which has not yet been paid over to him; that subsequent to January 15, 1932, and up to August 22, 1932, the said O. C. Hall, as Trustee, received for him the sum of One Hundred Thirty-three and 50/100 Dollars (\$133.50) per month, and that since August 22, 1932, and up until December 1st, 1932, the said O. C. Hall, as Trustee, has received for him One Hundred Fifty-seven and 50/100 Dollars (\$157.50) per month; that since December 1st, 1932, the said allowance coming to him from the Veterans Administration has been held by the Veterans Administration; that he is not advised as to the amount of cash or the collaterals that the said O. C. Hall, as Trustee, now holds for him.

That he is now and has been all of his life living with his mother near Bay Minette, Alabama; that his father died on March 10, 1929, and that since that time he has been called upon to provide and care for his mother; that his sister's husband died in 1922, and that up until the time of his father's death she and her children were provided for by his father, but that since the death of his father he has been called upon to provide and care for his widowed sister and her two minor children.

That his mother is now living on the farm about ten miles from Bay Minette and his sister has to live in Bay Minette so that the children can attend school; that during the past two years he has fully realized his responsibility, having been

called upon daily to furnish food and clothing for those dependent upon him, and has of necessity had to change his habits and manner of living.

That during the past two years he has also been called upon to oversee and direct the operation, in a manner, on his mother's farm; that he also has from time to time almost daily been called upon to carry provisions and necessities of life from Bay Minette to his mother on the farm.

That he has now reformed and changed his habits and manner of living and is fully capable of caring for, maintaining and managing his own estate.

That as a result of the Veterans Administration holding up the payments due for the months of December and January just past, he has been placed in embarrassing positions, having no funds with which to provide for his mother and widowed sister and children and taking care of their needs in attending school.



That said Estate of said Coy Mixon consisted of moneys received from the United States Government through its Veterans Bureau for back payment on a War Risk Insurance Policy held by the said ward, Coy Mixon, in the amount of \$7762⁵⁰ Dollars; such payment being for his total and permanent disability; that in addition to said principal the said ward has received from the Government the sum of Eighty-six Dollars (\$86.00) per month as compensation, and the further sum of Fifty-seven & 50/100 Dollars (\$57.50) per month as installments under said Insurance Policy all of which has been deposited to the credit of your Petitioner, as Trustee of the said Coy Mixon;

That since the appointment of said Trustee he has administered said estate, receiving and depositing to his credit as Trustee all sums of money received from the United States Government through its Veterans Bureau, and making such disbursements therefrom of such moneys as were necessary and proper for the maintenance of said ward according to his rank and station in life and the preservation of his property.
