made to the City of Mobile do hereby bind ourselves, and our heirs and assigns, jointly and severally, firmly by these presents.

Sealed with our seals, and dated the 5 day of June in the year of our Lord, one thousand
nine hundred and Sixty

The condition of this Obligation is such that whereas the said Robert Travis has on the
date of these presents claimed an appeal to the Circuit Court of Baldwin County, next to be held in and for the County of Baldwin, in the
State aforesaid, at the Present Session, thereof from a judgment rendered against him on the 4 day of June,
1960, for the Offense of Destroying City Property

by the Recorder of the City of Mobile State of Alabama.

NOW, if the said Robert Travis shall appear at the present Session of said Circuit Court,
and from Session to Session thereafter until discharged by due process of law, then this obligation to be void, otherwise to remain in
full force and virtue.

And we each do hereby waive all right of exemptions allowed us under the Constitution and Laws of the State of Alabama as to
the collection of this bond if forfeited.

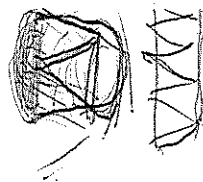
