The conditions of the above obligation is such, that, whereas, the above bounden  
Elizabeth Melton  
was, on the 30<sup>th</sup> day of July, 1960, convicted in the Municipal  
Court of the said City of Foley, of the offense of Driving While  
Intoxicated, and  
by the judgement of said Court sentenced to the payment of a fine of \$ 100<sup>00</sup>  
plus costs  
Dollars, or \_\_\_\_\_ days in Jail.

And, whereas, the said Elizabeth Melton has  
this day prayed on appeal from said Judgement to the Circuit Court of said County.

NOW, if the said Elizabeth Melton shall  
appear at the next term of the Circuit Court, and from term to term thereafter until dis-  
charged, and abide by and perform whatever sentence may be adjudged in said Court  
against her, then the above obligation is to be void; otherwise to remain in full force and  
effect; and each of us to waive our exemptions as to personal property.
