TO THE HONORABLE F. W. HARE, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, IN EQUITY SITTING:

Comes Amos Garrett, Complainant in the above styled cause and humply complaining against A. M. Grimsley: shows,

FIRST:

That your Complainant is over the age of twenty-one years and a resident of Robertsdale, Baldwin County, Alabama; that the said A. M. Grimsley is over the age of twenty-one years and a resident of Fayette, Alabama.

SECOND:

That your Complainant is the owner of and is in the actual, peaceable possession of the following described land, situated in the County of Baldwin, State of Alabama, ever claiming to own the same, to-wit:

The West half of the Northeast quarter of Section Twenty-one, Township Six South of Range Four East, containing 80 acres, more or less.

THIRD:

That the said Defendant claims or is reputed to claim some right, title or interest in, or encumbrance upon the above described land, or some part thereof, and your Complainant calls upon him to set forth and specify his title, claim, interest or encumbrance upon the same and how and by what instrument or instruments, the same is derived or created.

FOURTH:

That no suit is pending to enforce or test the validity of such title, claim or encumbrance upon the said land, or any part thereof.

Wherefore your Complainant prays this Honorable Court will take jurisdiction of the cause made by this bill of complaint and make the said A. M. Grimsley party defendant to this bill of complaint and by appropriate process require him to plead, answer or demur to the same within the time and under the penalties prescribed by law and the practice of this Honorable Court.

Complainant further prays that upon a final hearing of the cause made by this bill of complaint, this Honorable Court will order and decree that the said Defendant, A. M. Grimsley has no right, title or interest in, or encumbrance upon the said land or any part thereof, and that the title to the said property be quieted and established in the Complainant as against the said A. M. Grimsley, and that the said A. M. Grimsley be forever enjoined from asserting, or attempting to assert, from claiming or attempting to claim any right, title or interest in, lien or encumbrance upon the said land, or any part thereof, and Complainant further pray for such other, further or different relief as in equity he shall be entitled to receive in the premises.

FOOT NOTE:

The Defendant is required to answer every allegation of the foregoing bill of complaint, paragraphs first to fourth, inclusive, but not under oath. Oath being hereby expressly waived.
