

To the Honorable F. W. Hare, Judge of said Court:

Humbly complaining, your Orator respectfully shows unto this Honorable Court, as follows:

That your Orator is over the age of twenty one years, is a bona fide resident of this county, and has been a resident of the state of Alabama for more than three years immediately preceding the date of the filing of this bill.

That the Defendant is over the age of twenty one years and is a resident of the state of Alabama, at the county of Montgomery therein.

That at Montgomery, Alabama, on or about the 3rd day of October, 1924, your orator and the Defendant intermarried and that they ever since have been and now are lawful husband and wife.


That at Tuskegee, Alabama, in the spring of the year 1928, on to-wit: April 15th, 1928, the Defendant, without any just cause or excuse, and without his consent and against his wish, wilfully and voluntarily abandoned your orator, who was wholly without fault in the premises, and that such abandonment has persisted and been continuous for a period of more than two years next immediately preceding the date of the filing of this bill.

THE PREMISES CONSIDERED, your Orator respectfully prays that the said Defendant, Erin V. Joiner, be made party respondent to this bill of complaint by the usual process of this Honorable Court, and that she be required to demur, plead to or answer the said within the time and under the penalties as provided by law, or that the same be forever confessed.

P R A Y E R F O R R E L I E F:

Wherefore, your Orator prays that, upon the final hearing of this cause, the bonds of matrimony now and heretofore subsisting between himself and the respondent, Erin V. Joiner, be wholly dissolved, and that he be granted by this Honorable Court an absolute divorce therefrom, and that your Orator may have such other and further relief as to the Court may seem just and equitable in the premises.
