() Speeding

Did operate a motor vehicle upon a public highway in said County and State at a rate of speed in excess of that provided by law.

() Reckless Driving

Did operate a motor vehicle upon a public highway in said County and State carelessly and heedlessly in willful and wanton disregard of the rights or safety of others, or without due caution and circumspection, and at a speed or in a manner so as to endanger or to be likely to endanger any person or property.

() No Driver's License

Did operate a motor vehicle upon a public highway in said County and State without first obtaining a driver's license.

() Driving While Intoxicated
