19 *62*, *MR Howell* *City Recorder* a Justice of the Peace in and for said State and County,

rendered a judgment in favor of the said *City of Foley*
against the said *Hattie Minor* for the sum of
\$100.00 dollars, debt, and *8.50* dollars, costs, from which judgment the said

Hattie Minor has applied for and obtained an appeal to the *next*
term of the *Circuit* Court of *Baldwin* and the said *Hattie Minor*

shall prosecute said appeal to effect, or, if he fail in said appeal, shall pay such judgment, both as to
debt and costs, as may be rendered against him by the said *Circuit* Court of *Baldwin*,

then in either of said events, this obligation to be void, otherwise to remain in full force and effect.
