## BILL OF COMPLAINT

- l. Your complainant further shows to this Honorable Court that he has threatened further acts of violence toward her if an opportunity ever presented itself, and to do her grievous and bodily harm.

3. Your complainant further shows to this Honorable Court that to this marriage no children were born.

Premises considered, your complainant prays that Your Henor will take jurisdiction of this cause made by this Bill of Complaint and will cause notice thereof to be served on the respondent, EDWARD WEAVER, according to the rules of this Honorable Court and the laws of the state of Alabama in such matters pertaining, and make new a respondent to said Bill of Complaint, requiring him to answer, plead or demur within the time allowed by law.

Your complainant further prays that upon the final hearing

of this cause Your Honor will grant her a decree of divorce, dissolving the bonds of matrimony now existing between your complainant and the respondent, EDWARD WEAVER, granting her an absolute divorce, granting her the right to re-marry again, granting her the right to resume her maiden name, and for such other relief as equity in good conscience, your complainant will ever pray.
